## MANDATORY NDIS & CORPORATIONS SYSTEMS & POLICIES WITH BITE!

All NDIS registered service providers are experiencing greater scrutiny of their governance systems and policy documentation by the NDIS Quality and Safeguards Commission and the Aged Care Quality and Safety Commission as part of their registration renewal obligations

These systems and policies obligations include:

- Allied Health professionals' mandatory obligations to report critical incidents arising for eg. From what your client may reveal when working with you
- if applicable, meeting the behaviour support requirements, including reporting the use of restrictive practices to the NDIS Commission
- demonstrating compliance with the NDIS Practice Standards for your relevant registration groups
- compliance with the NDIS Code of Conduct in your organisation and support employees to meet its requirements
- fulfil worker screening requirements and ensure all workers have been screened
- ensuring all workers of registered NDIS providers complete the worker orientation e-learning module '*Quality, Safety and You*'.

In addition, for-profit companies and not-for-profit companies limited by guarantee, there is the Corporations Act requirements for a specific whistleblower protection system and policy.

This symposium shares experiences, model systems and policy documentation, and tips and traps in reviewing your organisation's compliance with mandatory NDIS and Corporations Acts' systems and policies requirements.

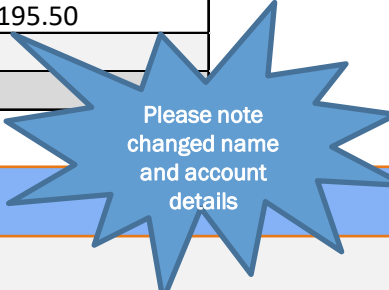
